Measure & CFC Position	Description & Status
AB 2395 (Low) - Oppose	Would have eliminated requirements for phone companies to maintain copper-line landline residential phone service, depriving millions of Californians from having reliable telephone service. <i>Held in Appropriations suspense file</i>
AB 2667 (Thurmond) - Support	Would have made it unlawful for a business contract to require a California consumer to waive the right to enforce a civil rights violation in a court of law. <i>Failed passage on Assembly Floor</i>
AB 2688 (Gordon) - Oppose	Would have enacted weak, tech industry-friendly privacy rules for wearable devices and apps that collect personal health information. <i>Withdrawn by author</i>
AB 2795 (Lopez) - Support	Would have prohibited telephone providers from charging additional fees for the privacy of an "unlisted" telephone number. <i>Died in Assembly Utilities Committee</i>
AB 708 (Jones-Sawyer) - Support	Would have required manufacturers of cleaning products to disclose on their websites the ingredients in their products. <i>Failed passage on Assembly Floor</i>
SB 1150 (Leno) - Support	Protects surviving homeowners from needless foreclosures and dual-tracking by banks by applying California's Homeowner Bill of Rights in cases of widowed homeowners who hold title to their home, and wish to assume the mortgage, but are not named on the mortgage note. <i>Signed into law.</i>
SB 1241 (Wieckowski) - Support	Prohibits an employment contract that mandates arbitration of worker disputes to require the arbitration hearing be held outside of California. <i>Signed into law</i>
SB 1441 (Leno) - Support	Would have prohibited the California Public Utilities Commission from allowing the cost of natural gas lost in the form of vented or leaked natural gas emissions from being recouped from ratepayers. <i>Died on Assembly Floor</i>
SB 3 (Leno) - Support	Increased the state's minimum wage annually to eventually reach \$15 per hour in 2022. <i>Signed into law</i>
SB 648 (Mendoza) - Sponsor	Would have required licensing for agencies that refer persons to residential care facilities for the elderly and mandatory disclosures to consumers explaining any fee arrangements between agencies and elder care facilities. <i>Vetoed</i>
SB 778 (Allen) - Support	Would have required automobile repair shops to follow the vehicle manufacturer's recommended oil drain interval when recommending a customer return for their next oil change. <i>Vetoed</i>
SB 899 (Hueso) - Sponsor	Would have prohibited retailers from gender-based pricing of consumer goods, marketed to women, at higher price than a similar or identical men's product. <i>Held in Assembly Judiciary committee</i>
